

Dear Valued Guest,

We are excited to welcome you to Lake O'Neill. In order to provide the most enjoyable experience for all of our military patrons and their families, there are several policies in place that we ask all guests to acknowledge and adhere to. Lake O'Neill Campground

- If reserved in a campsite with a fire ring. Straw waddles, treated wood, wood pallets, or wood with any metal hardware is not permitted and must not be burned at any time. All fires must be burned in the designated concrete fire rings in the campsite. Open fires are not permitted at any time and patrons are not authorized to bring their own fire pit/ring
- Maximum of 2 pets are authorized per site. All dogs are required to be on a leash that does not exceed 6 feet and must be always supervised by their owners. Pets are not permitted in restrooms, laundry room or lake and must be attended at all times while in the campsite. Vaccination must be current. A nightly Pet fee of \$3.00/pet will be imposed on all guest accounts for campsites with pets.
- Please be respectful of your neighbor and the shared environment, properly police your area for any debris and pick up any trash before you depart. Pet feces must be picked up and properly disposed of pet waste bags are available throughout the campground. Burying of pet feces is strictly prohibited. Cleaning fees will be assessed if excessive trash is left in the fire pit or in the campsite
- Each RV site is authorized one RV or one Travel Trailer/Camper, plus two vehicles and one 10x10 pop up shade canopy. If no RV or Travel Trailer is present, then 2 4-person tents and two vehicles are authorized. *Sleeping accommodations must not exceed 8 persons in any campsite. Each campsite is authorized one additional tent for a nightly fee of \$12.00.*
- Each TENT site is authorized two 4-man tents or one 8-man tent, plus two vehicles. If camping in section 2, sites S2P, S2Q, S2R, S2S you are authorized one pop-up camper with one 4-man tent, plus two vehicles. *Sleeping accommodations must not exceed 8 persons in any campsite.*
- Patrons are prohibited from the appearance of "homesteading" in any fashion. Homesteading is defined as permanent or unsightly structures or fixtures erected, to include but is not limited to fences, clothes lines, gazebos; etc. Any structure or fixture must immediately be removed by patrons upon the request of management.
- Each campsite will be provided designated parking permits. Permits must be placed inside the vehicles and/or RV/trailer and must be always visible. All vehicles must have current registration. A *\$25.00 nightly parking* fee will be assessed on all guest accounts for any additional motorized vehicle parked in the campsite that does not have a parking permit.
- Registered vehicles with the proper issued parking passes are authorized in the RV Park. Day visitors must park in the enclosed parking lot adjacent to the RV/Campground Security Office and playground.
- Military Sponsors must always remain on site. Civilian guests and children under the age of 16 must not be left unaccompanied. If the Military Sponsor is not present, the civilian guests will be asked to vacate the site. Day guests must vacate at quiet hours, 2200.
- RV/Travel Trailer must be always in operational condition with current registration and all wheels must remain on the trailer. All patrons must always have a tow vehicle available. Camper shells/cab overs must be always left on /in the bed of the truck.
- Section 2-3 and sites 44-49 are all back in sites. No backing in on pull through sites.
- Due to Environmental Security, washing and repairs to any motorized vehicles throughout the campground is strictly prohibited.
- Box/Storage trailers are not permitted in the campground. If temporary storage (3 days maximum) is needed patrons may rent a tent site to place their box/storage trailer in. Long-term storage is available off site at Recreation Checkout (760) 725-5296.

- Please be advised that due to increasing electrical issues with our RV pedestals we recommend the use of surge suppressors to protect your equipment. The power pedestal can produce a maximum of 50 AMPs. If this power is exceeded and damages occur to the patron's personal property, MCCS is not liable for damages.
- MCCS is not liable for damage caused to patron-owned property due to weather or local wildlife.
- Check Out is 1100, late departures will be assessed a late fee of one night's rental rate. For your convenience, campsites may vacate without stopping by the front office. A copy of your receipt will be emailed to the address on file.
- Please be advised that any violation of the above policies may require immediate eviction from the facility and forfeiture of all payments/deposits.
- <u>Cancellation Policy:</u> Any modification during your stay will result in a non-refundable fee of one night's rental rate. Remaining balance will be refunded to the credit card on file. <u>Holiday Block:</u> Upon the day of check in, your total balance will be non-refundable.
